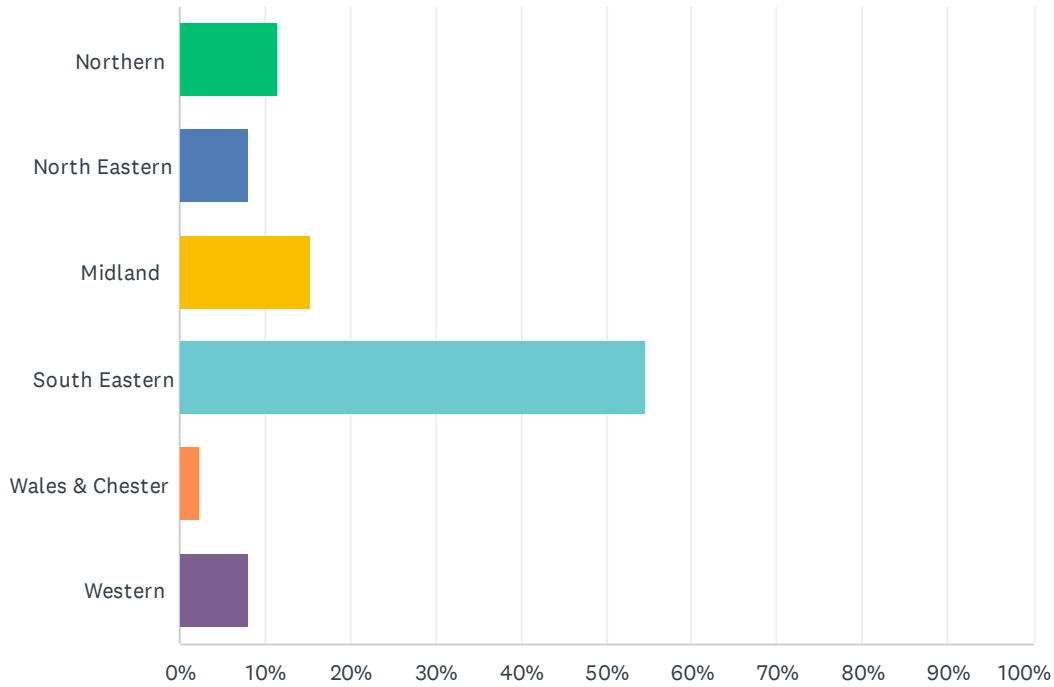

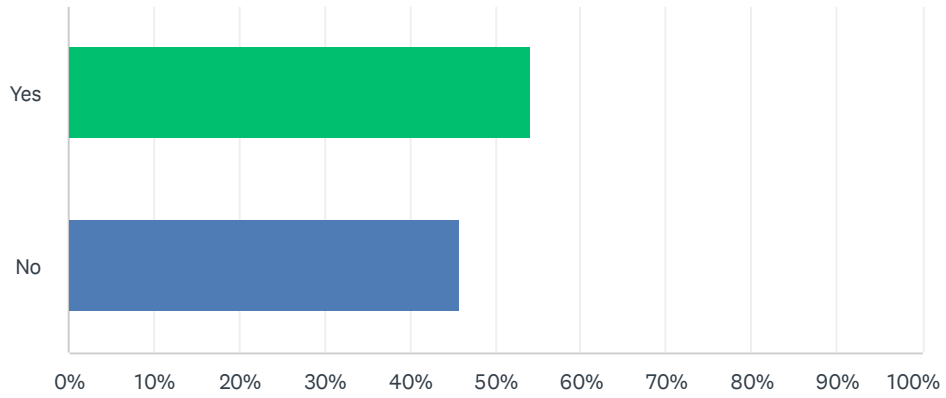

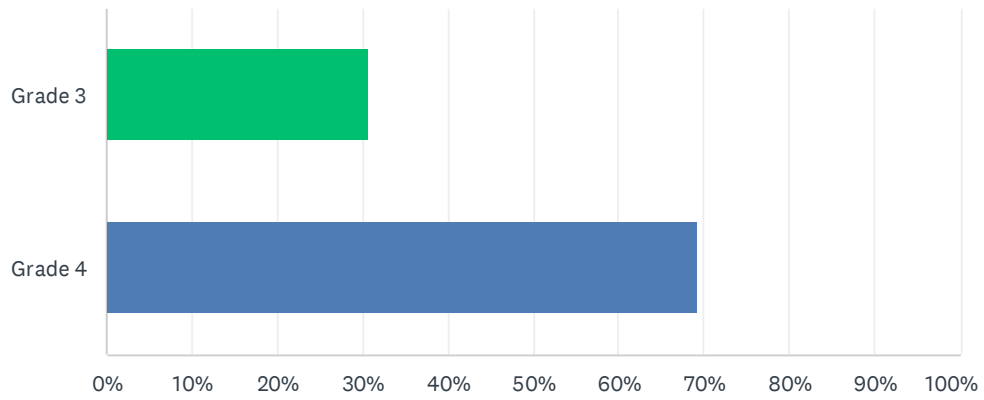

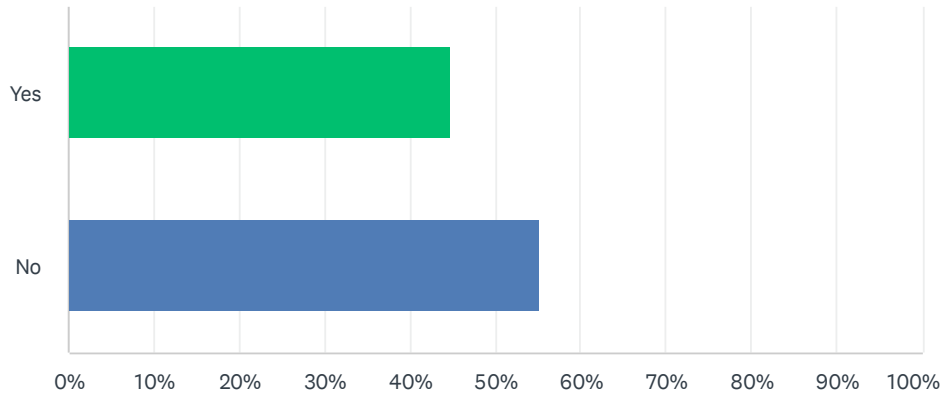

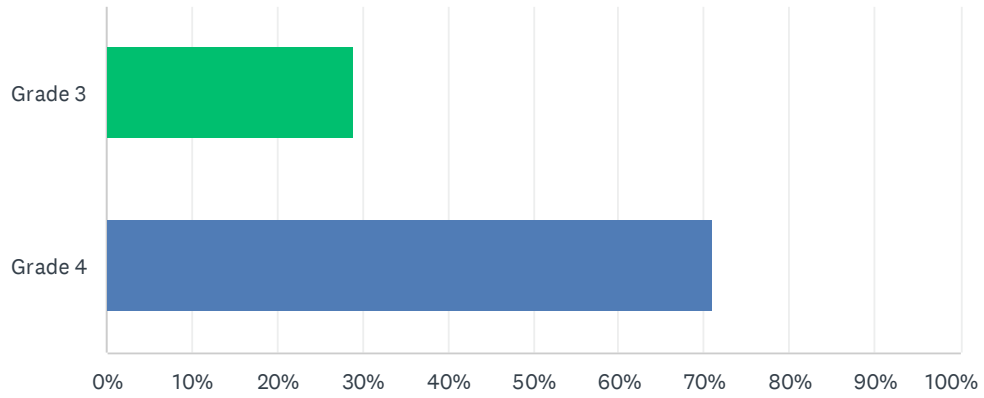

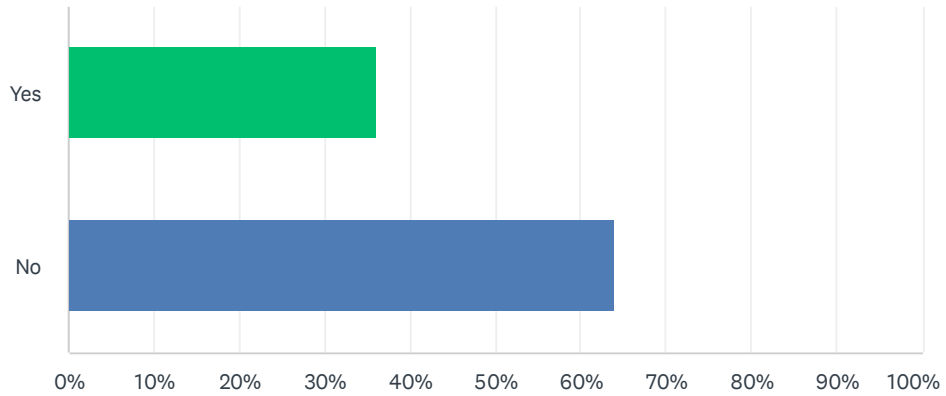

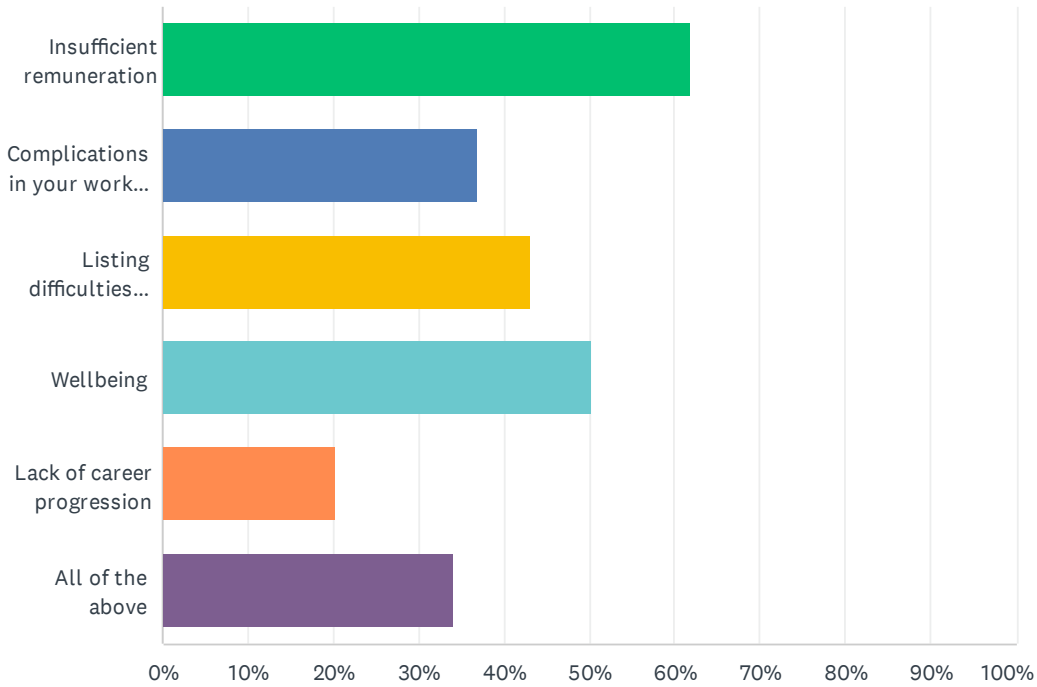

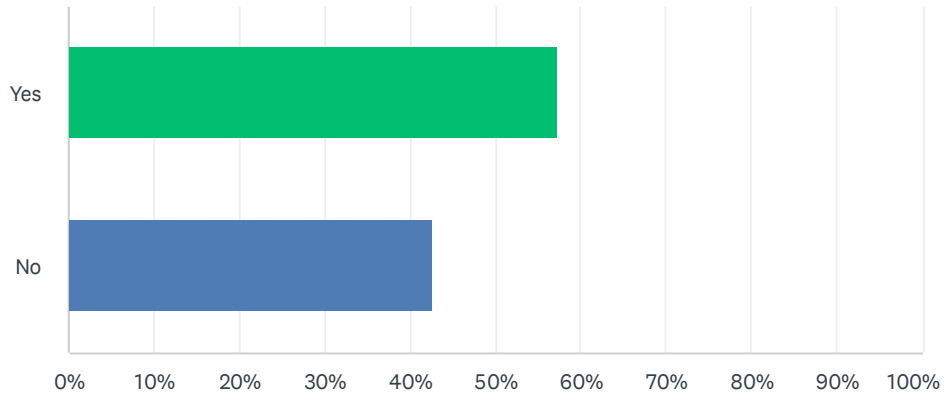

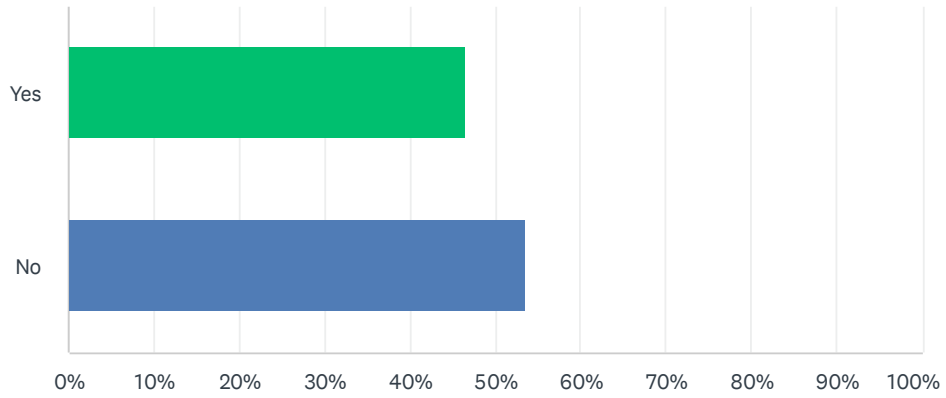

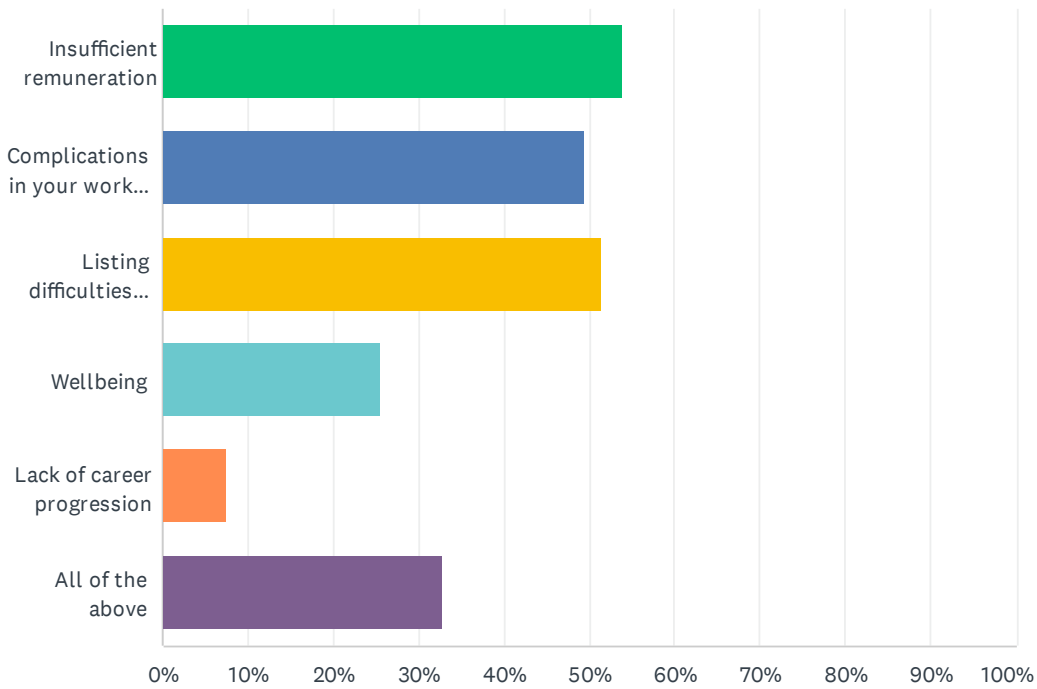

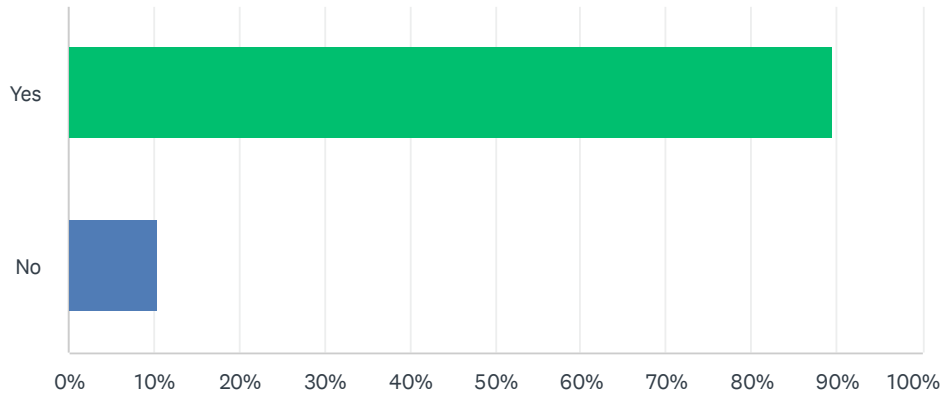

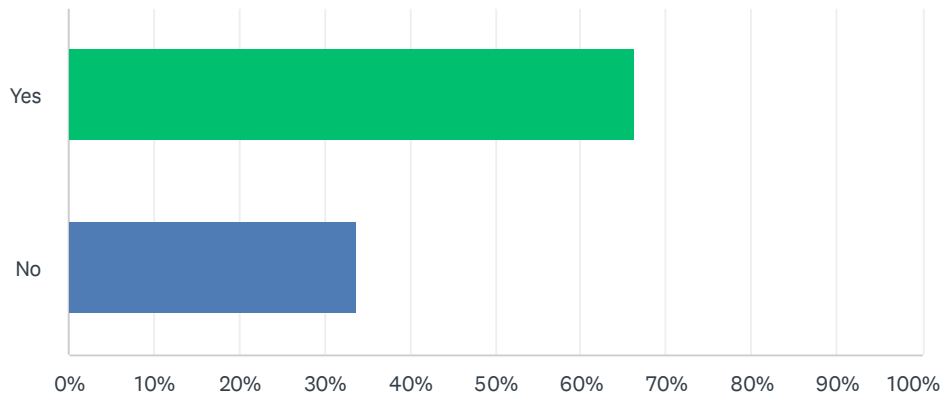

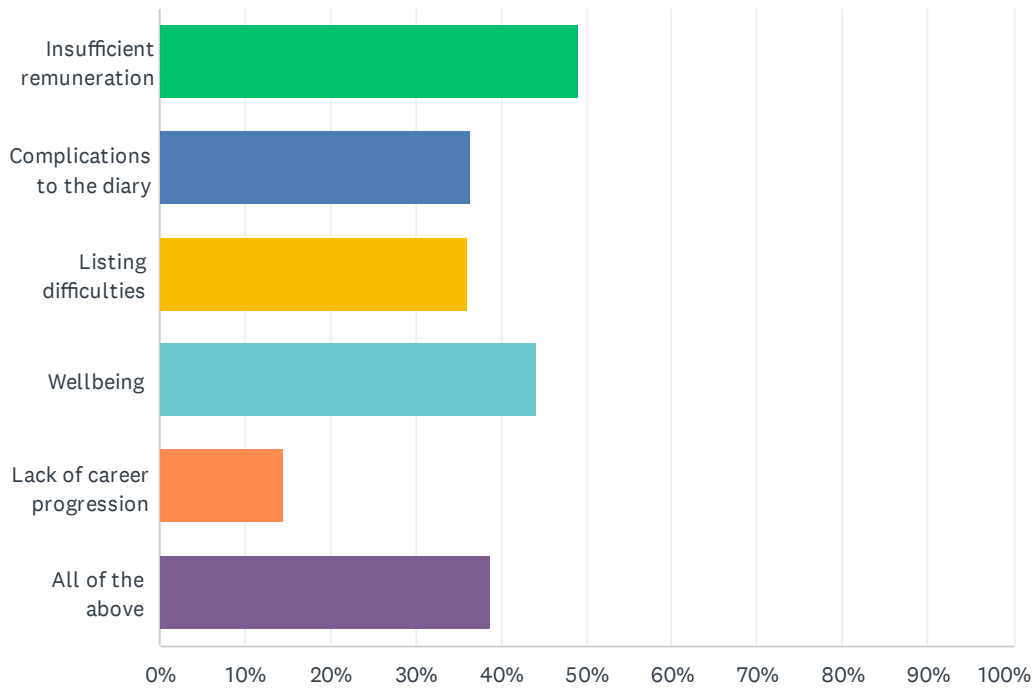

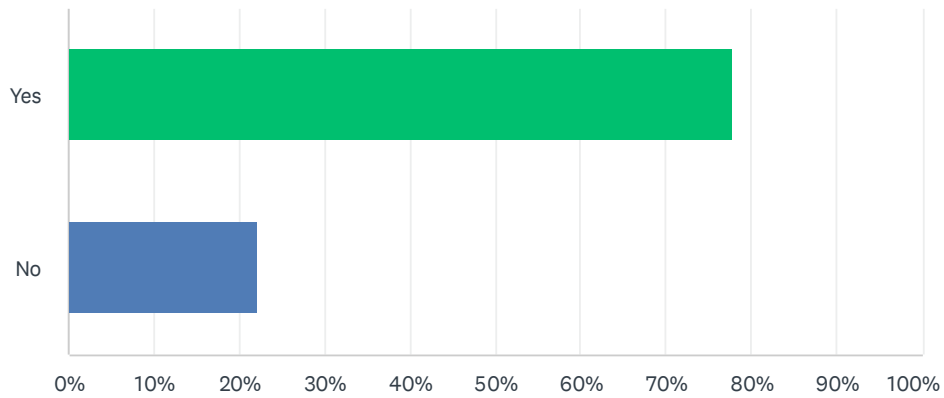

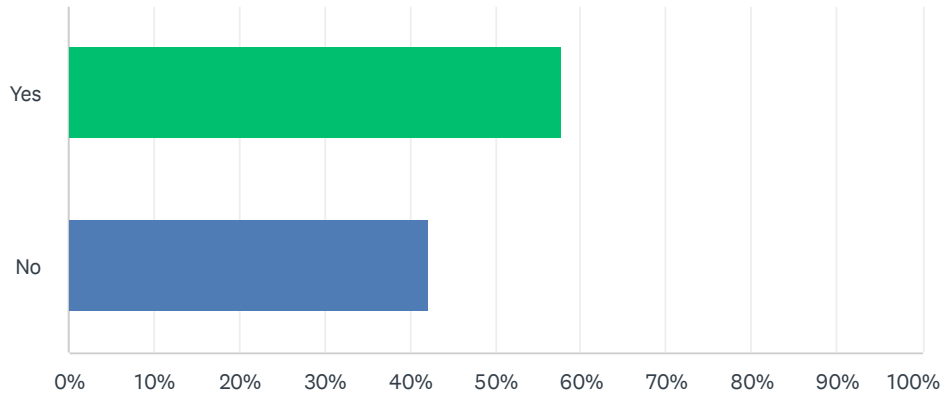

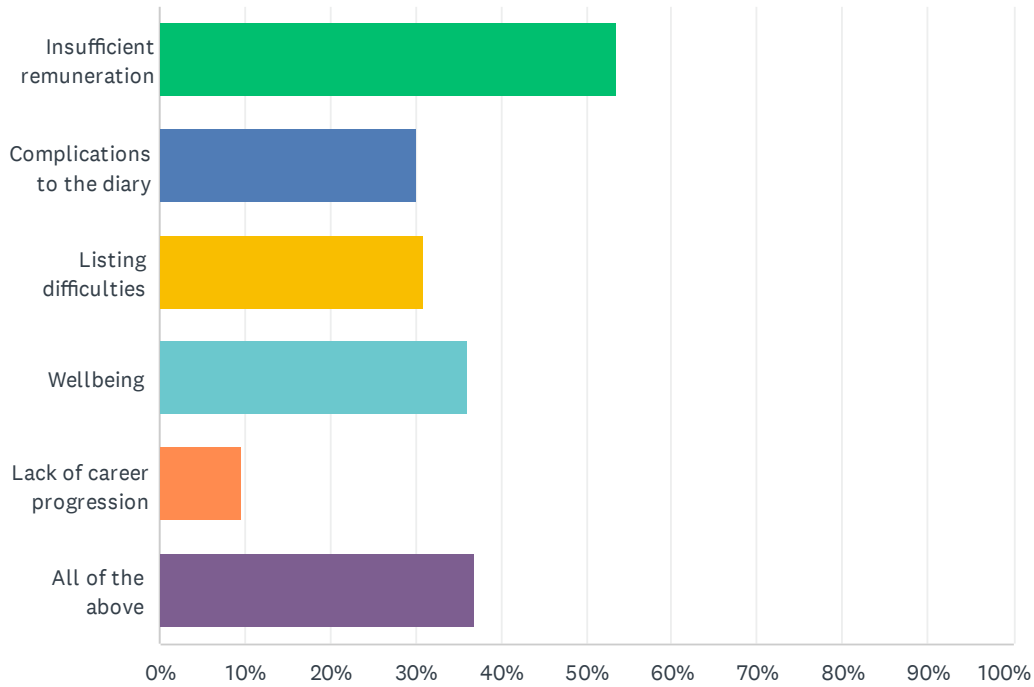

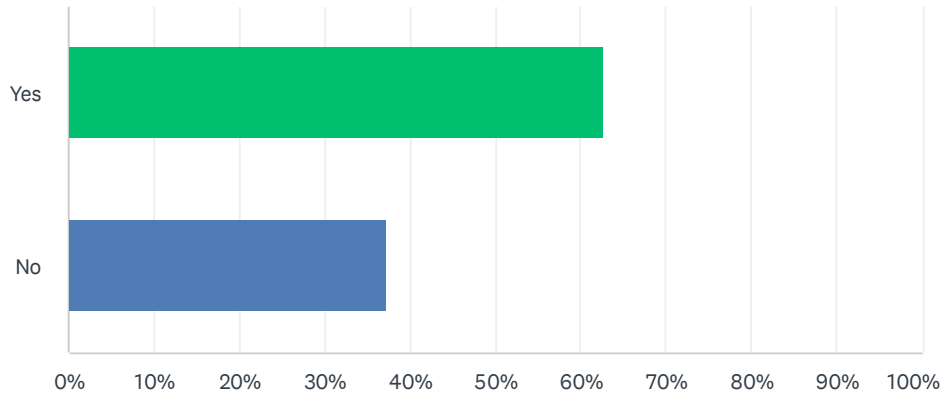

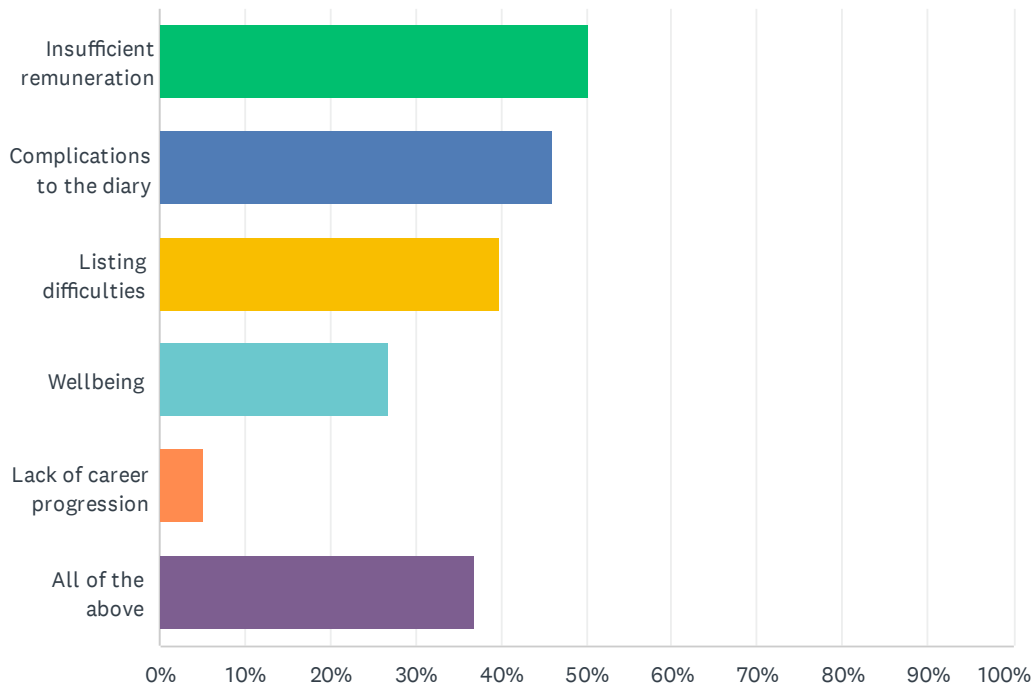

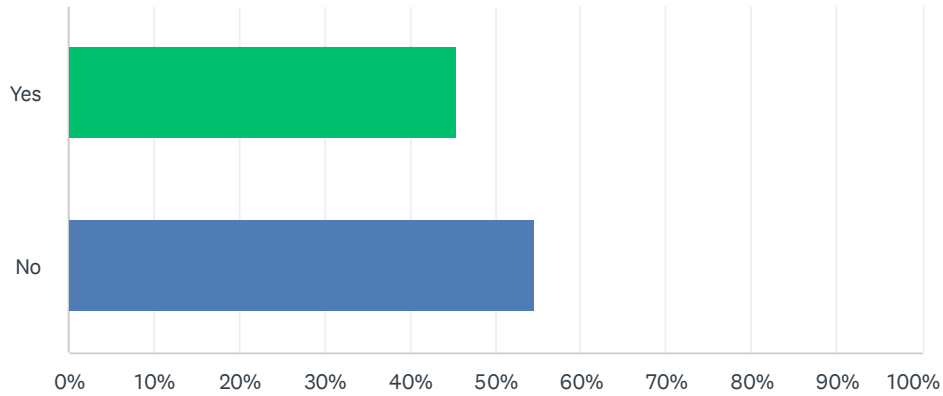

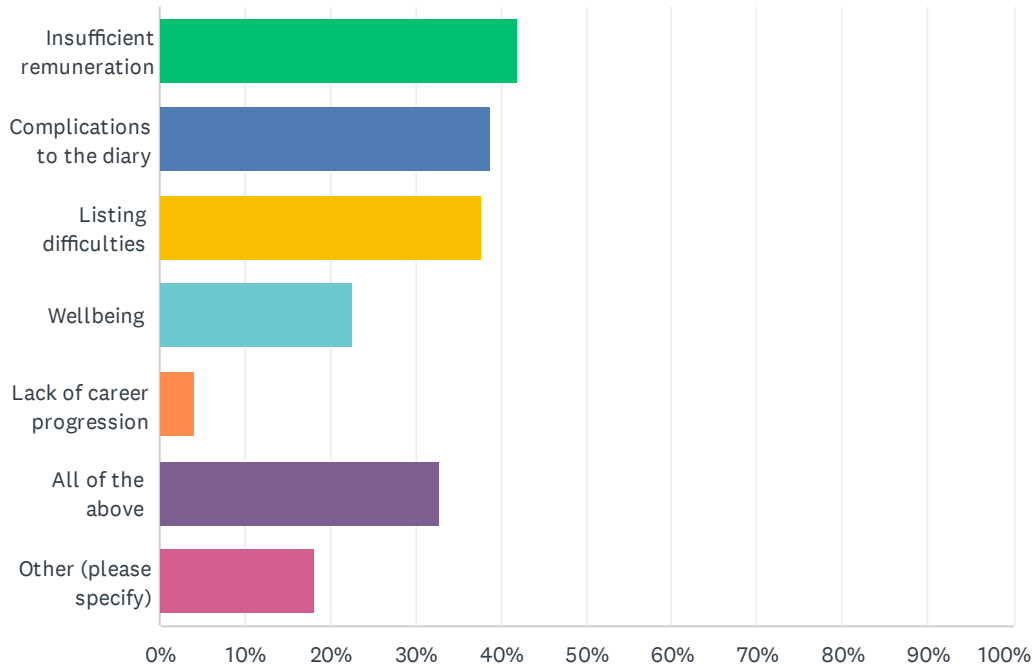

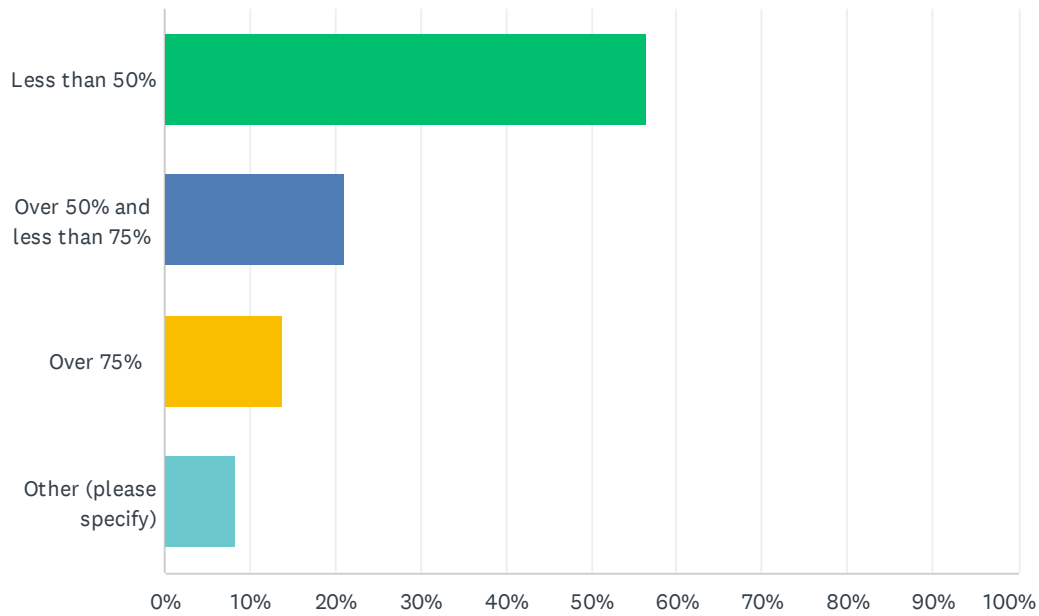

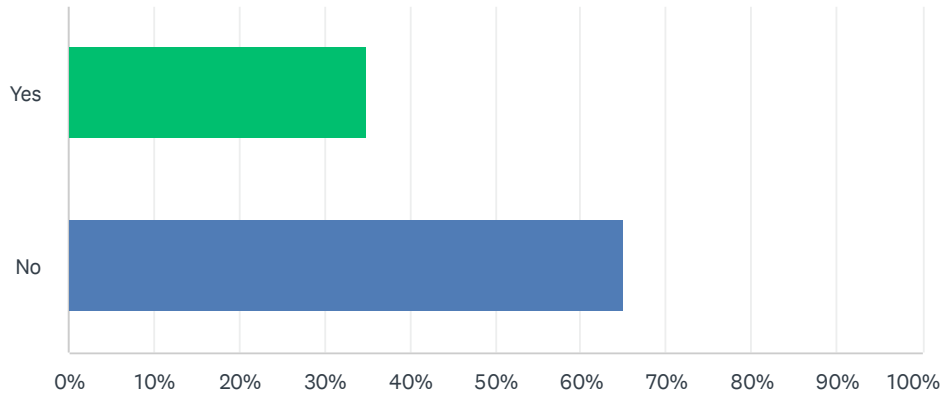

## Q23 Has the amount of RASSO work you conduct decreased in the last 12 months?

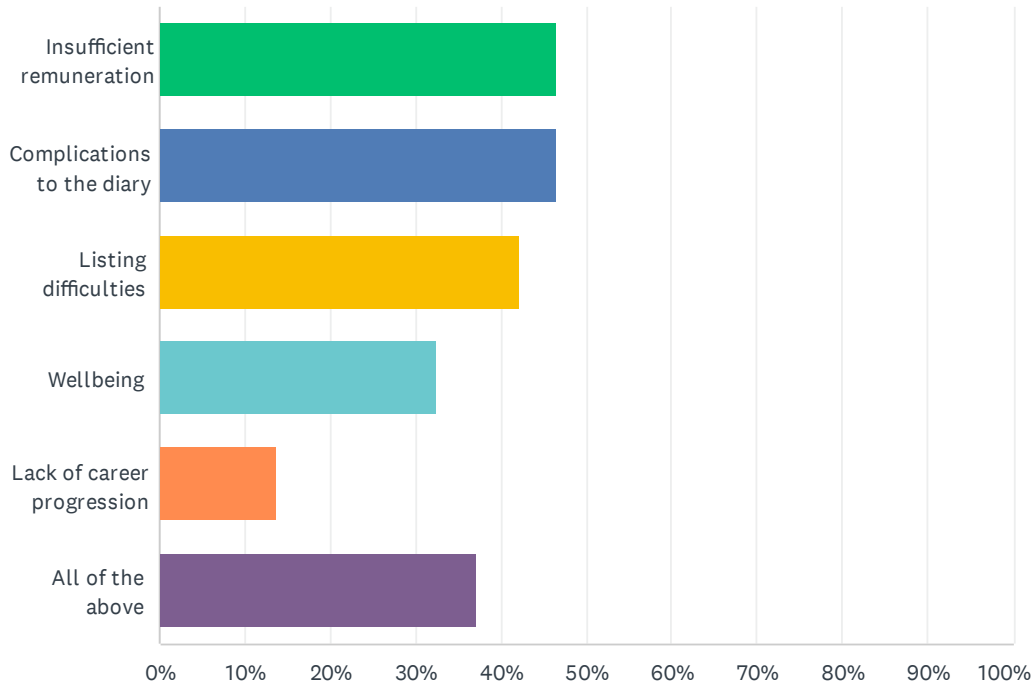

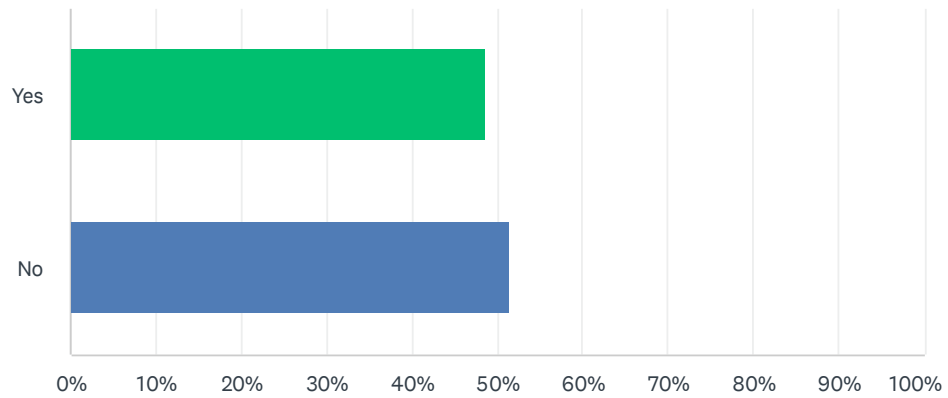

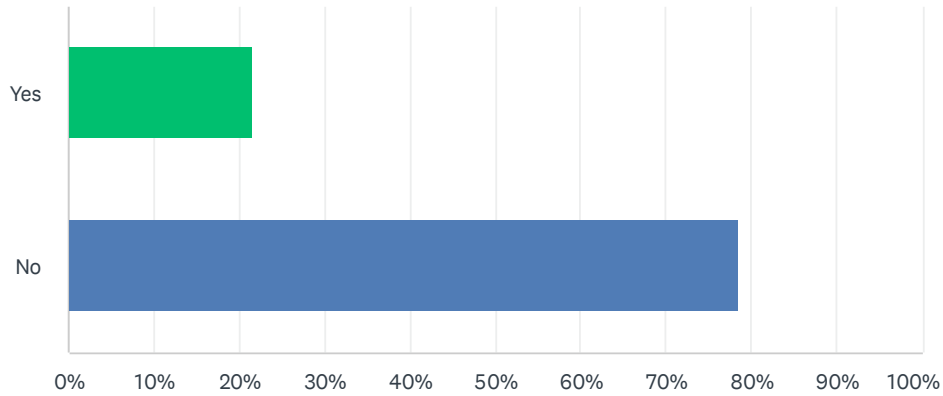

## Q26 If you are under 5 years' Call, do you intend to build a practice which includes RASSO work?

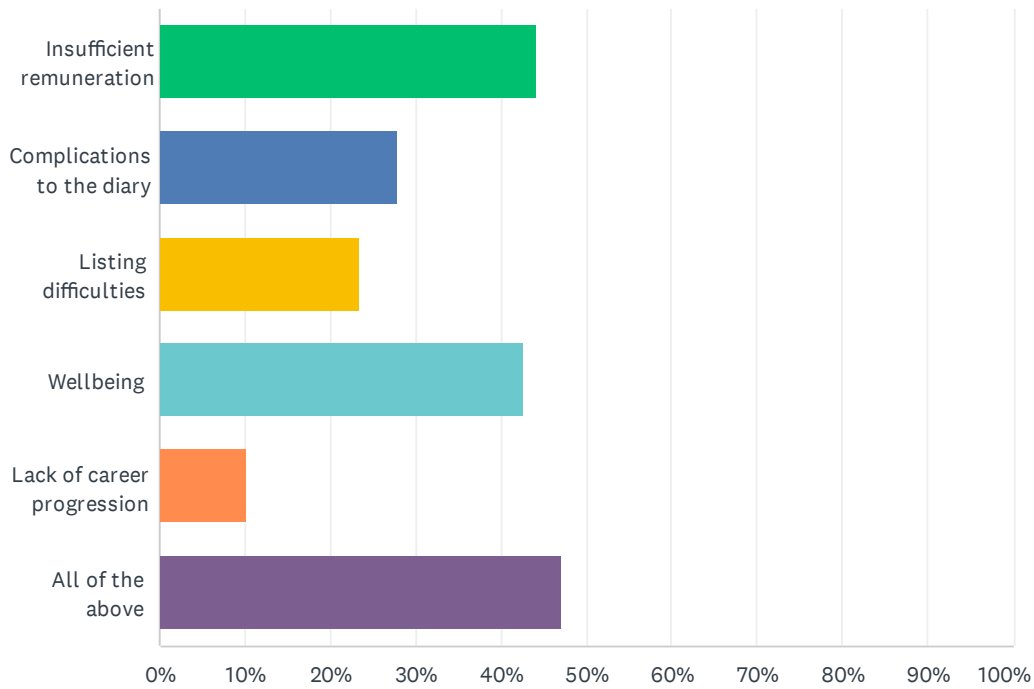

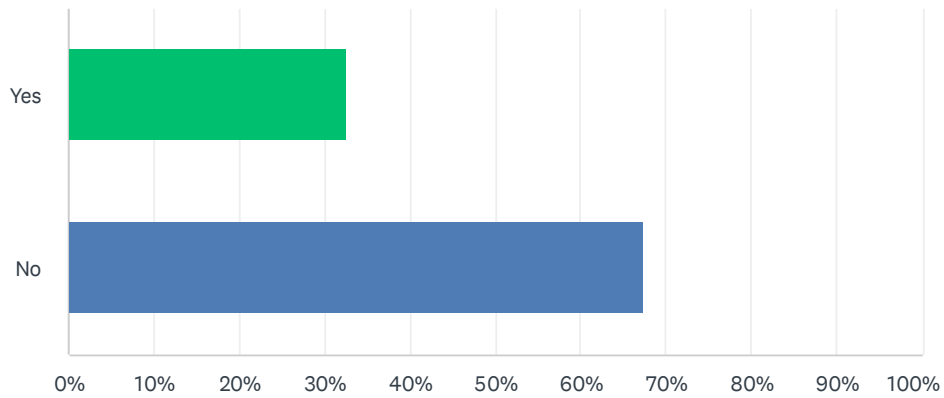

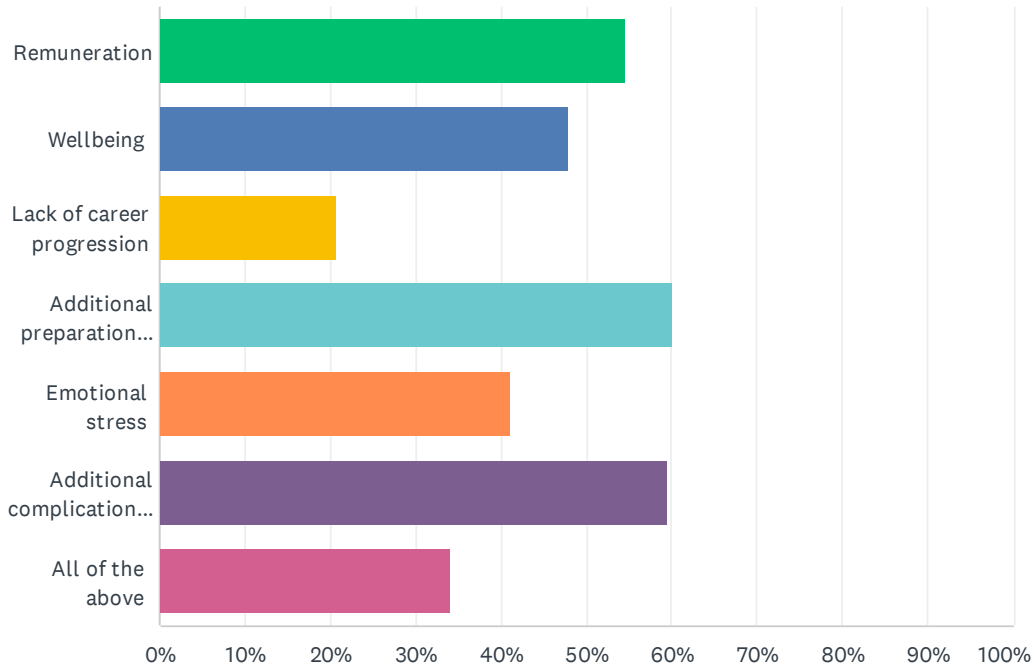

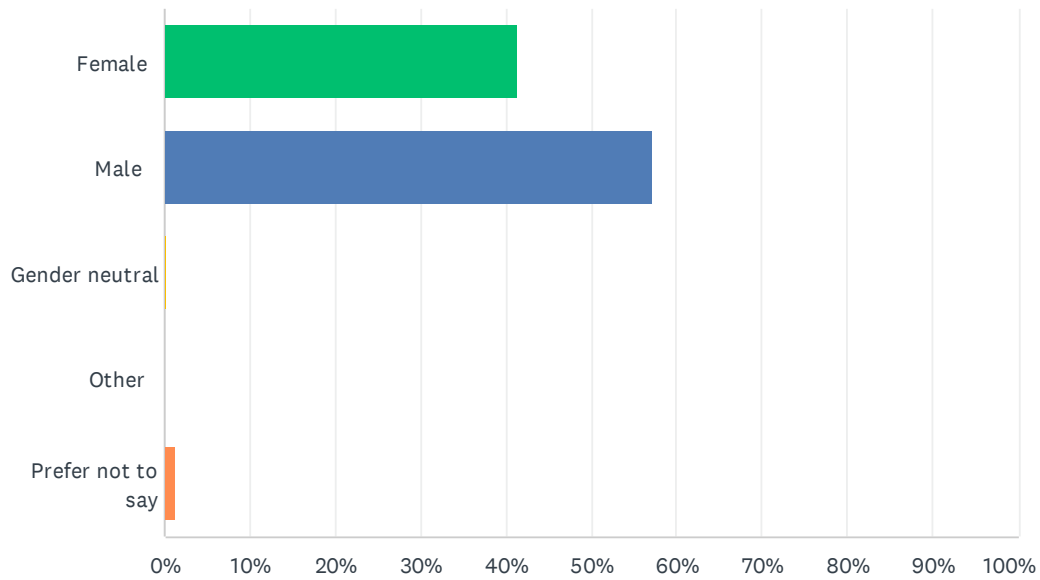
