

## **List of Specialist Regulatory Advocates in Health and Safety and Environmental Law and Appointment of Standing Counsel**

On 31<sup>st</sup> March 2012 the Attorney General's Unified List of Prosecuting Advocates will come to an end. The Health and Safety Executive, Environment Agency and Office of Rail Regulation wish to appoint a list of advocates to conduct their higher court prosecution work and other regulatory advocacy. HSE and ORR also each wish to appoint two Standing Counsel.

By agreement the HSE will be undertaking the administration arrangements for the selection process on behalf of the members of the Regulatory List Board. However the selection process itself will be conducted jointly by all three bodies. It is intended that all future instruction of counsel in prosecution and ancillary matters by the HSE, EA and ORR will be by reference to the Regulatory List

**APPOINTMENT OF STANDING COUNSEL  
TO THE DEPARTMENT FOR BUSINESS, INNOVATION AND SKILLS (BIS)**

The Department for Business, Innovation and Skills prosecutes a range of offences, primarily relating to personal or company insolvencies (further details can be found on the Department's website). Standing Counsel to the Department are instructed to provide strategic advice on complex issues emerging in its criminal work, and to advise and prosecute in the Department's most serious cases.

### **Vacancies**

Our present Standing Counsel appointments expire in April 2012. Consequently, the Department has vacancies for up to six Standing Counsel in England and Wales. Appointments will be made for three years with the possibility of an extension to a total of five years at the Department's discretion.

Successful applicants are expected to adhere to the Department's Standing Counsel Protocol (available as part of the application pack) including prioritisation of Department work.

### **Eligibility**

Applications are welcome from experienced barristers or solicitors with higher court advocacy rights. No specific length of call or practice is required, though applicants are expected to have substantial post qualification experience. It is expected that most applicants will have previously prosecuted cases on behalf of the Department, although this is not essential.

Applicants are expected to demonstrate significant experience of:

- advocacy in serious and complex fraud prosecutions, including company and / or personal insolvency related aspects of fraud;
- proven ability to draft clear and practical written advices and skeleton arguments on legal, procedural and evidential issues, within a short time-frame;
- handling large-scale / complicated disclosure exercises under CPIA;
- POCA restraint and confiscation regime;
- working for government departments / CPS and an appreciation of the special demands and policy implications of government / CPS prosecutions.

### **Application**

All applicants are required to complete an application form and submit two pieces of written work. Applicants are also required to provide up to three professional references, completed on a pro-forma form. The Selection Board will recommend for appointment those applicants who appear to be best qualified regardless of ethnic origin, gender, marital status, sexual orientation, political affiliation, religion, age or disability.
